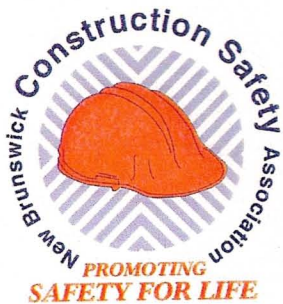



The Letter of Good Standing has three states, your firms status is indicated by the appropriate marked block.

In the Process

Firms who employ an individual who has completed the necessary NBCSA management training, as well as satisfied their training obligations as outlined by the Occupational Health and Safety Act, may apply for a Letter of Good Standing in the "In-Process" state. A firm who has submitted the 1st audit of the 1st cycle and not achieved a successful review will automatically enter the "In-Process" state as well. This is a one-time process valid 6 months.

Audit Pending

Upon receipt of an internal audit, and a successful review of same by the NBCSA, an audit date or time period will be set by Audit Department. Firms who have completed this process will be considered Audit Pending. This state is valid for 90 days and renewable with cause.

Certificate of Recognition

The certificate of recognition is awarded to firms who have completed the training requirements, fully implemented a loss control program, and successfully participated in the Audit process. This certificate is valid for a period of one year.

Certificate of Recognition - Anniversary Audit Review

Certified firms in good standing, currently participating in an anniversary audit review will remain in good standing allowing for review of their internal audit.

Grace

Companies that are COR certified that have not submitted their internal audit results before the expiry date of their existing letter will be entitled to 90 days of Grace. This means that their 'Letter of Good Standing' is no longer valid and that they have 90 days to submit the required information to be reinstated to the COR state, or they will be put into the 'Lapsed' state.

Lapsed

A member that fails to meet NBCSA requirements, in excess of the 90 days after the expiry date of their last 'Letter of Good Standing', is designated as 'Lapsed'. A lapsed company no longer possesses a current and valid 'Letter of Good Standing'. In order to resume the audit process, a member that has lapsed must submit an additional internal audit with a complete safety manual to NBCSA for review. On acceptance of the submissions, the member is considered 'Audit Pending'. Costs associated with the additional audit are the responsibility of the lapsed company.
